Supporting and Protecting PARENTAL RIGHTS

Seeking to fulfill a promise I made on the campaign trail; I am co-sponsoring a series of 13 House bills that focus on protecting the rights of Pennsylvania parents regarding the education and well-being of their children.

I look forward to working with my House colleagues in moving these important proposals through the legislative process.

Some of the measures I have co-sponsored include:

- House Bill 158, which would ensure females are not forced to compete against biological males playing on women's sports teams.
- House Bill 236, which would remove an exemption currently allowing school libraries to possess and exhibit any legally obscene or highly sexual content.
- · House Bill 246, which would prohibit state-funded schools from requiring the completion of diversity courses or other classes that negatively impact some students.
- House Bill 248, which would require parental notification and consent for student participation in school-related clubs and organizations.
- · House Bill 252, which would require parental notification and written consent for a student to access and use a mental health digital platform promoted or facilitated by school entities.
- House Bill 581, which would prohibit classroom instruction on sexual orientation and gender identity in kindergarten through fifth grade; require classroom instruction be age appropriate; and mandate that public schools adopt procedures for notifying parents if there is a change in services regarding a child's mental, emotional or physical health or well-being.
- · A bill not introduced yet that would ban drag queen shows on public property or in areas that can be seen by minors and classify such events as an adult-oriented business.

State Budget Process UNDERWAY

We are working hard in Harrisburg on the 2025-26 state budget. Back in February, Gov. Josh Shapiro unveiled his budget proposal, which would spend \$51.47 billion. That's an increase of \$3.57 billion, or 7.5%, over the current year.

With revenues projected to increase by just 2.8%, the governor's plan would fully deplete the state's surplus funds and would again dip into the Rainy Day Fund, as well as require revenue from new taxes on things like recreational marijuana and skill games.

This approach is unsustainable. We must instead focus on policies that expand the economy and create familysustaining jobs. There is great growth potential in our energy industry alone, and I look forward to advancing policies that support these goals.

However, my top concern with the governor's proposal is the way in which education funding is being allocated. Rural school districts are being short-changed. In fact, two smaller school districts in our area would receive just a 0.6% increase in Basic Education Funding yearover-year and they are talking about cutting band, art and extracurricular activities. Meanwhile, an urban school district next door is getting 12-14% more. The current funding formula is unfair and is crushing Pennsylvania's rural school districts.

The General Assembly and governor face a June 30 deadline to finalize the budget.
